

Minutes of the Meeting Of the

Red River Parish Police Jury held on the

6th day of AUGUST 2018

THE RED RIVER PARISH POLICE JURY met on Monday August 6, 2018 at 7:00p.m., in the Police Jury Assembly Room, Located in the Red River Parish Courthouse, Coushatta, La in its Regular meeting with President Shawn Beard presiding. Roll Call and attendance was recorded as follows:

Invocation by Mr. Davis and pledge by Mr. Brown.

Visitors – Mrs. Mary Jones, Registrar of Voter of Red River Parish, announced her retirement which will be August 31, 2018.

New Business

On the motion of Mr. Moore, seconded by Mr. Brown to approve minutes as written for July, 2018. Motion Carried.

With Mr. Brown making the motion, followed with a second by Mr. Hillman September 3, 2018 Jury meeting was changed to Thursday September 6, 2018 due to Labor Day holiday and Board of Review. Motion Carried.

On the motion of Mr. Brown, seconded by Mr. Murray to renew Dana Moseley Contract for Jail Nurse for the Year September 1, 2018 thru August 31, 2019. Motion Carried.

Red River Employee's Appreciation dinner is set for October 18, 2018 at Lakewood Inn, 6:00 pm.

Mr. John Perkins was appointed to the Red River Port Commission on the motion of Mr. Moore, followed with a second by Mr. Brown. Motion Carried.

Finance

Mr. Brown made the motion seconded by Mr. Hillman to pay the bills for the month of July, 2018. Motion Carried.

On the motion of Mr. Moore, seconded by Mr. Murray it was approved to pay the invoice from LSU AgCenter for \$10,000.00. Motion Carried.

RESOLUTION

BE IT RESOLVED, that the following millage(s) are hereby levied on the 2018 tax roll on all property subject to taxation by Red River Parish Police Jury.

PARISH TAX: GENERAL ALIMONY	3.63
PARISH TAS: EXEMPTED MUNICIPALITIES	1.81
RED RIVER PARISH LIBRARY	7.09

BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Red River, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2018, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property

subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

The foregoing resolution was read in full, the roll was called on the adoption thereof, and the resolution was adopted by the following votes:

RESOLUTION

SECTION I: BE IT ORDAINED, by the Police Jury of Red River Parish, State of Louisiana, in regular session convened that the year 2018, there shall be levied on Acreage Tax of Eight Cents per acre on all forest lands and cut over potential forest lands, situated in the Parish of Red River, State of Louisiana, and that the said lands shall not include the following:

1. Lands Subdivided for town sites.
2. Lands classified and used primarily for Agriculture.
3. Lands fenced and used primarily for pasture purpose.

SECTION II: That the acreage tax herein levied shall be assessed and extended in the same manner as the assessment and extension of the Tax Rolls and other Parish Taxes, and that the Assessor shall classify the forest lands to be taxed hereunder in said parish subject to the approval of the Louisiana Tax Commission.

SECTION III: That said acreage tax shall be collected by the Sheriff and Ex-Officio Tax Collector for the Parish of Red River in the same manner as other Parish taxes, and when so collected shall be remitted to the Department of Government having jurisdiction for the practice of Forestry in this state for the deposit into a fund known as State Forestry Fund.

SECTION IV: That the funds derived from taxes levied hereunder and deposited in the State Forestry Commission for the purpose of protecting the forest lands of said Parish from damage of fire and causes in accordance with the provisions of Act of 1990, Regular Session of the Louisiana Legislature.

On motion of Mr. Davis seconded by Mr. Moore, the foregoing resolution was adopted, by unanimous vote, in regular and legal session on the 6th day of August, 2018.

Ambulance

Mr. Hillman made the motion, seconded by Mr. Brown to approve to pay bills for the Ambulance District for the month of July, 2018. Motion Carried.

On the motion of Mr. Moore, seconded by Mr. Murry the meeting was adjourned.
